INDEPENDENT REVIEW REPORT- YOUTH WITHOUT BORDERS LTD

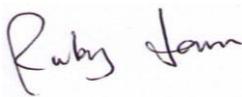
We have completed the review of the financials for Youth Without Borders for the year end 30 June 2014 and enclosed our review report.
